

Franklin County Commissioners and Chairman,

The hauling contract previously in place had Franklin County paying \$30.48 per ton to haul the county's waste. With that contract expiring, we sent out four bid packets with hopes of a similar contract. Bid packets were opened on August 1, 2024 with only one bid from BFI submitted. That contract raises the cost to haul per ton to \$53.60. New suggested rates to offset this substantial increase are as follows:

Residential Services \$25.00/month Extra Can \$15.00/month

Late Fees \$5.00 assessed after the 15th of each month

Secondary Dwelling \$150.00/year

Dumpsters \$40.00 additional fee per dumpster

Landfill Residential \$65.00 per ton Landfill Inert \$30.00 per ton

In addition, I request free residential drop-offs at the landfill are no longer accepted after December 31, 2024.

This rate adjustment will be reflected on the January 2025 billing statement and cover increased operational expenses associated with the rising cost of providing waste collection. Franklin County residents have not seen an increase in their monthly rates since 2005, almost 20 years ago.
